

WAIVER FORM
I-80 SWAP MEET AT THE BARN

I understand that the flea market is a privilege extended to vendors or exhibitors who have merchandise to sell or display which is related to motorcycles. No motorcycle dealers allowed.

Behavior: I understand that SWEET MARY'S PROMOTIONS and Big Barn Harley-Davidson and their agents reserve the right to restrict participants and spectators to acceptable behavior during all activities within the assigned swap meet areas and the Big Barn Harley-Davidson properties. I agree not to display or sell late H-D brand motorcycles newer than 2000-year models, t-Shirts with unseemly or questionable wording or pictures, drugs, or paraphernalia of any nature related in any way to drugs, alcoholic beverages food or drinks or the permitting of any unlicensed drivers and/or drivers under 16 years of age to operate motorized vehicles on the premises.

I understand this is a family-oriented event and willingly will cooperate in the NO COLORS allowed on the swap meet and Big Barn Harley-Davidson properties during this event. Although one or two vintage leathers and/or t-shirt per vendor will be accepted, there will be no 100% leather, t-Shirt or jewelry vendors allowed.

Liability: In consideration for the rights to participate, participants and spectators (by execution of this form) release and discharge SWEET MARY'S PROMOTIONS, BIG BARN HARLEY-DAVIDSON, their officers, agents, directors, employees, workers, volunteers, representatives of and members at large from any and all known and unknown damages, injuries, losses, judgments, and claims from any cause whatsoever that may be suffered by any entrant, spectator passenger or his or her property. For value hereby received, i.e., my rights to use the facilities provided to sell my wares. I hereby confirm that I am familiar with all the state tax rules and regulations pertaining to the law and that if tax money from my transactions is due to any state, city, or other taxing authority, I will collect same, file all reports necessary and save the SWEET MARY'S PROMOTIONS and the BIG BARN HARLEY-DAVIDSON harm from any and all other liabilities which may incur to SWEET MARY'S PROMOTIONS and the BIG BARN HARLEY-DAVIDSON from any of my transactions, be it tax or any other liability arising out of my transactions.

The flea market starts at 9 a.m. Saturday June 16th, 2018 and set-up must be complete by this 9 a.m.
The flea market closes at 5 p.m. Saturday June 16th, 2018 (unless specifically advertised otherwise) and vendors are to vacate the meet sight no later than 10 a.m. Sunday June 17th, 2018. As you depart you will leave your assigned areas clean and free of debris. I understand if I do not abide by the rules, management can eject the entrant and / or vehicle from the premises. Ejection may cause loss of any future eligibility of this event. I agree to comply peacefully with all the above stated expectations and with verbal clarification of the SWEET MARY'S PROMOTION and the BIG BARN HARLEY-DAVIDSON PERSONNEL.

Vendors who choose not to vacate the premises until the following day (Sunday June 17th) by 10 a.m., there will be reserved parking for them and their trailer on sight just east of the vendor set up area. This parking area is within sight of the vendor set up area. I understand that there will be no policing and or security for the vendor areas after 5 p.m. Saturday, June 16th and I if I leave my wares exposed overnight it will be at my own risk.

This parking area is primitive and there are NO electric, sewer and/or water hookups available. Electric cords from parking area and/or any other areas will not be allowed in the vendor set up area.

ADMITTANCE WILL NOT BE ACCEPTED WITHOUT SIGNATURE. Your signature certifies that your tax I.D. information and your vendor status is correct and that you acknowledge Sweet Mary's Promotions and Big Barn Harley-Davidson's rules and will abide by them while in attendance.
